## 3. Sharing of Information

We do **not** sell or rent your personal data to third parties.

We may share data only in the following cases:

- **Service Providers:** with trusted vendors who help us operate the App (e.g., hosting, analytics, customer support).
- **Legal Compliance:** when required by law, regulation, or government request.





- **Business Transfers:** in case of a merger, acquisition, or sale of assets.

## 4. Data Security

We implement reasonable security measures to protect your personal data. However, no method of transmission or storage is 100% secure, and we cannot guarantee absolute security.

## 5. Children's Privacy

The App is **not directed to children under the age of 13**. We do not knowingly collect data from children. If we become aware of such collection, we will promptly delete the information.

## 6. Your Rights

Depending on your state of residence, you may have rights regarding your personal information, including:

- Requesting corrections or deletions.
